All religious groups who apply and are approved to participate are encouraged to focus their presentation in a manner that will not be offensive to others who do not share their beliefs and is focused on the purpose and goals established by the Steilacoom Chamber Fourth of July Mission Statement for this event.

### **Participation**

The Steilacoom Chamber of Commerce Fourth of July Committee reserves the right to revoke previously approved participation by any participant before or during the parade or street fair if the participant's presentation does not match that of the content of the approved application, exceeds the scope of the approved application, or is determined to be unsafe.
